** Please initial all spaces with a blank line.

_____ The Artwork submitted is original work by the artist, completed within the last 2 years, not under academic supervision.

Mass-produced objects or craft kits are not accepted.

2D works must be properly framed with required D-rings and wire on the back for hanging.

Art on canvas must be gallery-wrapped with all sides painted, and the required D-rings and wire on the back for hanging.

No saw tooth hangers on frames and canvases are allowed.

3D works should be free-standing or able to fit on a gallery pedestal.

Works needing special installations must be provided by the artist and approved by The Art Center.

Artists 18 years and older residing in the United States are eligible to enter.

_____ The Artwork submitted must remain on display at the gallery for the duration of the dates listed for the particular jury show.

_____ Insurance for art entered is the responsibility of the Artist.

_____ The Art Center does not accept responsibility of theft, vandalism or damage caused by gallery patrons or staff or caused during transfer for any reason, including mishandling by carrier or failure of packaging to protect works in transit. Also not covered is damage caused to work by failure of the work itself, or its mounting systems installed by the Artist.

_____ All work must be for sale.

_____ The Art Center will take a 40% commission on all work sold by non-members. (Commission on works sold by TAC members will be according to artist agreements per member status)

_____ If a work of art is sold, The Art Center, will provide payment to the Artist in check form within thirty (30) days of sale, minus the 40% commission due to the Art Center.

_____ Regardless, if a work of art is sold by the Art Center or the Artist themselves, while your work is on display at the Art Center, the Artist is ethically responsible and contractually bound to give the 40% commission to the Art Center.
